



**Important informations for candidates provisionally shortlisted for  
Practical Test and Interview for the posts of Restorer**

1. Practical test (30 marks) shall consist of following three parts:
  - (i) In word processing/type test of 10 marks, candidates shall have to type a given paragraph of 200 words in 10 minutes.
  - (ii) In spread sheet/M.S. Excel test of 10 marks, candidates shall have to draw a table and answer the questions using commands/formulas in 10 minutes.
  - (iii) In an objective type multiple choice test of 10 marks having 20 questions ( $\frac{1}{2}$  marks each) and of 10 minutes duration, questions shall be asked to check the operational knowledge of computers and use of internet.
2. All the candidates who have been shortlisted for practical test shall also have to appear in the interview to be eligible for consideration for appointment.
3. A candidate shall have to secure a minimum 40% marks each in practical test and interview in order to eligible for consideration of appointment.
4. Final result will be prepared on the basis of the total marks obtained in practical test and interview.
5. Date time and venue will be announced in due course.
