It is for the information of all concerned candidates who have been shortlisted for the Computer Proficiency Test for the posts of Clerk in Subordinate Courts of Haryana that the Computer Proficiency Test will be held tentatively on 21.11.2020, 05.12.2020 & 19.12.2020. The date 07.01.2021 is tentatively fixed as reserved date. Admit cards indicating the date, time, and venue of the examination will be uploaded in due course on the website [www.sssc.gov.in](http://www.sssc.gov.in)

Pattern for the said Computer Proficiency Test will remain same as mentioned earlier in Notice No. 327/S.S.S.C. dated 24.02.2020. Moreover, the candidates are duly informed that the Health Advisories issued by the Government of India and State Governments with respect to conducting examination in the wake of COVID-19 pandemic would be duly followed at the examination centre. The candidates are advised to strictly follow the Health Advisories issued by the Government of India and State Governments with regard to COVID-19 from time to time. Detailed instructions to the candidates in this regard would be mentioned in the admit card and the candidates are required to read them carefully and observe them at the time of examination. Further, candidates are directed to inform this office in case he/she finds himself/herself COVID-19 positive before 04:00 P.M.(supported with COVID-19 positive report) at least one day prior to the scheduled day of his/her examination. The candidates are further informed that the dates

of 21.11.2020, 05.12.2020 & 19.12.2020 are tentatively fixed at a gap of 14 days as the general recovery period for COVID-19 is about 14 days so that in case any candidate is suffering from COVID-19 or exhibiting any of the symptoms of COVID-19, on the date of his/her examination, he/she could be adjusted in the remaining batches. In case, if any of the candidates who would be appearing for examination on 19.12.2020, is suffering from COVID-19 or exhibiting any of the symptoms of COVID-19, then the examination of such candidates shall be held on the reserved date.

It is also informed that the dates for the Computer Proficiency Test are tentative and the same may be changed as per the guidelines issued by the Government of India and respective State Governments from time to time.
